As part of the NRW state network against labor exploitation, we help and provide guidance:

- Are my employment contract and wage statement correct?
- Do I receive all statutory guaranteed benefits?
e.g. continued payment of wages in case of illness, vacation, overtime hours, nighttime surcharge, holiday pay, etc.?
- What should I do if I am dismissed or if I have problems with my employer?
e.g. missing work equipment or instructions, missing breaks, retained documents (e.g. ID cards), etc.?
- and many other questions on the topic of work and labor exploitation

We also offer:

- Help in finding legal assistance for employees in exploitative working conditions
- Arrangement of translation and language services for people seeking advice in other languages
- Information and contact to further help and advice services

Support Orientation Perspectives

For questions about your unemployment

We work with you to develop goals and opportunities for your future and search for solutions:

- Information and advice on rights for unemployment benefits (ALG) I and II (Citizen's benefit)
- Support in communication with authorities
- Support in developing new perspectives, e.g. further training opportunities or integration measures
- Support in career orientation and qualification, career planning and job search
- Assistance with the acknowledgement of school and job qualifications for people with an immigration background
- Guidance function in case of psychosocial problems, legal problems, such as labor law, contract law, tenancy law, debts, drug problems, etc.
- If necessary, forwarding to specialized counseling centers
